#### HGV'S – PONTEFRACT ROAD

Noise and Dust Committee / Letter from Concerned Residents

Cllr. J. Staveley – Churton advised he had attended the recent meeting on Wednesday 3<sup>rd</sup> September and reiterated the work Cllr. C. Fox is currently doing. Three letters from concerned residents were circulated to council members prior to the meeting for consideration. After discussions with residents present at the meeting and Cllr. C. Fox it was proposed by Cllr. N. Megson to invite all companies who have HGV's passing through Snaith to a meeting to discuss the future seconded Cllr. G. Hulme and agreed. Cllr. J. Staveley – Churton advised if large numbers of vehicles pass through one location an Air Quality Test can be requested to be done by the leading Authority. Cllr. J. Hollas proposed writing to ERYC asking for an Air Quality Test seconded Cllr. G. Hulme and agreed.

#### MARKET PLACE – DISABLED PARKING RESIDENTS CONCERN

A letter from a resident was circulated to council members prior to the meeting stating that non-disabled people were continuing to park on the disabled parking bay on Market Place. Cllr. G. Hulme proposed writing to ERYC asking for more Traffic Warden Patrols seconded Cllr. G. Laughton and agreed

#### EAST COWICK FOOTPATH – RESIDENTS CONCERN

A letter from a resident was circulated to council members prior to the meeting advising of a number of overgrown hedges and trees. Cllr. G. Hulme advised he had visited the site and the Hedge was overgrowing the footpath along with other areas not only in East Cowick. Cllr. G. Laughton proposed contacting the property owner / developer asking them to cut back the hedge seconded Cllr. G. Hulme and agreed. Cllr. J. Hollas proposed all councillors looked at their own areas for overgrown hedges and trees and report back to the Clerk at the next meeting seconded Cllr. G. Hulme and agreed

#### EADON PLACE – BIKING ON FOOTPATH

The Town Clerk advised of a residents concern of people biking on the footpath between Mill Balk Place and Bourn Mill Balk Road. Cllr. N. Megson advised that the resident is unhappy as a man hole cover is making a large amount of noise when bikes and scooters are travelling over it. Cllr. N. Megson proposed contacting ERYC and Yorkshire Water asking them to assess the man hole and replace if possible seconded Cllr. G. Laughton and agreed.

#### SNAITH YOUTH CLUB

The Town Clerk advised interviews for the Level 1 and 2 Youth Workers would take place on Wednesday 17<sup>th</sup> September. Decisions will be made in principle but will be taken to the full council meeting on Monday 22<sup>nd</sup> September 2014. Noted by Council Members

##### Play Area Inspection.

Cllr. G. Laughton agreed to carry out monthly inspections of the Princess Diana Playing Fields. Noted by Council Members.





#### Joint Use Play Area.

The Town Clerk advised the fence had been repaired and prices had been gained for the netting at the Joint Use Play Area. JUPA Committee to discuss at the meeting on 30<sup>th</sup> September 2014. Noted by Council Members

#### New Equipment.

The Town Clerk advised new equipment would be installed week commencing 15<sup>th</sup> September 2014. Cllr. G. Laughton advised she did not agree with purchasing any further large equipment for the play area. Cllr. N. Megson stated he would like it putting on record that he was very pleased with the purchase of the new equipment. It was agreed to discuss the issue of more equipment in 6 months

#### FREEDOM OF SNAITH


Cllr. J. Staveley – Churton advised he was in the process of organising a date for the Freedom of Snaith. Noted by Council Members
