WIND FARM COMMUNITY FUNDING

Cllr. J. Barrett advised he had received a complaint regarding the overgrown garden of 7 High Street, East Cowick and had reported to Pet Control within the ERYC. Noted by Council Members

Bourn mill Balk Road – Mud on Road – Cllr. N. Megson

Cllr. N. Megson advised mud had been left on the road by farm vehicle and it had taken several days for this to clear and he believed this to be unacceptable. Cllr. J. Barrett stated this could be an offence as it is a danger to other road users. Cllr. J. Barrett proposed contacting ERYC and Humberside Police seconded Cllr. G. Laughton and agreed

Street Lighting Issues on Mitten Avenue – Cllr. J. Staveley – Churton

The Town Clerk read a number of emails from ERYC advised they do not have responsibility for the light and it is home owners of Mitten Avenue who are responsible. Cllr. J.
