Public Participation

Community Speed Watch

Information was read to councillors from the Community Speed Watch Scheme coordinator regarding the legalities and criteria to run community speed watch on streets in Snaith and Cowick. The Town Clerk advised she had informed Cllr. J. Staveley — Churton of the situation and he would be speaking to interested volunteers. Cllr. H. Miley proposed speaking to the volunteers to see if they wanted to continue with the scheme and contacting ERYC asking if they were happy for the group to carry out the project om Selby Road seconded Cllr. J. Hollas. All councillors present voted in favour.

Police Update

Advertising

Stall Erection and Dismantling

The Town Clerk asked what procedures the council wish to put in place from the moving and erection of stall for the Christmas Market. Cllr. H. Miley proposed writing letters to all community groups in the area asking to support the event as well as gaining quotes from employment services to hire stall for the event seconded Cllr. L. Thomson. All councillors voted in favour.
