A grassed area outside of the ex ERYC properties on Finnleys Lane, West Cowick have been assessed and the East Riding are now considering tarmacking the area


Summer Market


A full list of events and timings was given to council members. The Town Clerk advised she would give a full list of responsibility’s out at the next meeting.
