East Riding Councillors Report

Update on Flooding in Snaith and Cowick February / March 2020

A pre-written letter to the Environment Agency and a timeline of events covering February and March flooding was read to council members by Cllr. S. Jones. Cllr. J. Hollas thanked Mrs Russell for preparing the timeline. Cllr. R. Spencer proposed forwarding the letter to the Environment Agency with a reply by date of 15 June 2020 seconded Cllr. L. Thompson, voted and agreed in favour by all. Cllr. D. Bromley proposed writing the letter to the Chief Executive of the Environment Agency and forwarding the letter to Andrew Percy MP and the ERYC seconded Cllr. J. Hollas, voted and agreed in favour by all.

Update on Covid19 Support Group - SCRVSG

Cllr. S. Jones gave an update on the fantastic work SCRVSG were doing in the community and advised the group had now made the decision to become a CIC therefore the Town Council would no longer be able to be involved with the running of the group as it was a business. Cllr. R. Lyons and Cllr. J Whiteley advised they were still volunteering for the group. Cllr. S. Jones expressed thanks to the councillors volunteering and hoped the council would still support and advise the group in the future if requested to do so. All councillors expressed thanks to the group. Cllr. S. Jones advised a letter of thanks had been sent to the group together with a formal letter informing of the council's position now the group had become a CIC. Noted by all council members.

East Riding of Yorkshire Council Support

The Town Clerk advised the group there was limited numbers of staff working for the ERYC and only essential work would be carried out. The Town Clerk also noted all officers of the council were working remotely from home. Cllr. C. Fox noted staff on the ground such as grounds maintenance were working with limited numbers. Noted by council members.

North Yorkshire Planning Application – Cllr. J. Staveley – Churton

Cllr. J. Staveley – Churton requested the Town Council make a formal objection to a planning application taking place close to the boarders of North and East Yorkshire as traffic from the application will have a large impact on our community seconded Cllr. R. Lyons. Cllr. J. Staveley – Churton proposed sending a letter of support to Heck Parish Council seconded Cllr. R. Lyons, voted and all agreed in favour.

Parking Issues - Punton Walk - Cllr. D. Bromley

Cllr. D. Bromley advised of a parking issue on Punton Walk. The Town Clerk advised the issue was domestic and the Town Council could not be involved. Cllr. D. Bromley requested he support the resident raising the issue. Cllr. S. Jones advised he must make the resident aware he is not acting as a member of the council. Noted by council members.
