
Action log

ERYC – 3 Step Poster

Information and copies of the East Riding of Yorkshire Council three-step poster was circulated to council members. Council stated they hoped to get people back into the High Street as soon as possible as long as it was safe to do so. Cllr. David Bromley expressed concerns with the lack of support given by the Town Council. Cllr. Joanne Whiteley stated the council must follow government guidelines. Noted by council members.
Cllr. Jim Hollas proposed purchasing floor stickers to be placed along Market Place and High Street advising of social distancing. Seconded Cllr. Joanne Whiteley.

Correspondence from Councillors

George Street Parking

The Town Clerk advised East Riding of Yorkshire Council highways was soon due to visit site and would look at the problem. Cllr. Joanne Whiteley proposed contacting the fire station and asking them if they had issues with access on George Street seconded Cllr. Jim Hollas

HGVs Selby Road

The town clerk advised Humberside Police were aware of the issue and the Assistant Clerk continue to send letters to HGVs not adhering to the weight limit.

HGV West Cowick

A complaint from a concerned resident regarding speed of HGV vehicles in West Cowick was read to council members. Cllr. Jim Hollas proposed speaking to the proprietor of the shooting school to request hauliers reduced speed seconded Cllr. Laura Thompson.

Garden Waste Saffron Drive

Information from a concerned resident was circulated to council members prior to the meeting. Counsellors were advised this was private land and not the Town Councils responsibility. Cllr. Jim Hollas proposed writing to the land owner requesting advice be handed out to people who were dumping garden waste in the area seconded Council John Staveley - Churton.

Snaith Community Playing Field – Cllr. J Hollas

Cllr. Hollas advised the playing field was the last bit of open green space for the community to use and the Town Council must defend the area and the goalpost that have recently been installed. Noted by council members.
