Humberside police

Representatives from Humberside Police attended the meeting to inform the Council of current crime levels and what was taking place within the community with regards to a police presence. The Town clerk asked for clarification on community support officers. Inspector Powell advised he had no knowledge of anything taking place like this in the community however a community officer has no powers and there would be large cost implications. Inspector Powell agreed to forward information to councillors by email on the current levels of police enforcement and with regards to traffic and HGV movement within the community.

Beast Fair
