Bus Shelter

The Parish Clerk explained a letter had been distributed to properties close to the proposed area for a new bus shelter, asking if they object to the installation. To update at a future meeting.

Christmas Lighting

The Town Clerk explained the costs of installing an electrical socket at Spa Well Lane and forwarded an email from ERYC for consideration. Cllr. James Hollas proposed arranging a meeting with Jubbs to discuss seconded Cllr. Richard Lyons and agreed.

Speed Signs

Information on costs were circulated to council members prior to the meeting for the purchase of new speed signs.

Cllr. Richard Lyons explained the speed signs coming into Snaith on Pontefract Road are not activated until cars are entering the parish. Cllr. R. Lyons proposed contacting ERYC and requesting they assess the timings are changed seconded Cllr. G. Williams and agreed.

JUPA Resurfacing

Costs for the resurfacing the path at the Joint Use Play Area were read to council members. Cllrs. agreed the costs were too expensive. Cllr. G. Williams proposed gaining quotes for a Tarmac path as it does not need to be safety flooring seconded Cllr. James Hollas and agreed.

Christmas Market


The Town Clerk Confirmed the date of the Christmas Market.
